How It Works

The AltaClaro Model

AltaClaro's mission is to be a pioneer and leading provider of experiential learning in practical lawyering skills and continuing legal education. Thus, the focus of AltaClaro Intensives, our core course offerings, is on the practical over the theoretical; the doing over the listening.

AltaClaro's courses are designed to offer participants the opportunity to acquire hands-on knowledge and to apply this knowledge and develop and refine their practical lawyering skills through simulations and real-time feedback.

The emphasis on simulations engages and challenges students to practice these skills in context, using real-life scenarios, and allows them to receive individualized feedback on their work—all in a “safe” environment.

Overview of Course Offerings

Courses at AltaClaro are taught in “modules.” Each module focuses on a specific topic and includes a 1-hour group lesson, a related “take-home” simulation exercise and a 1-on-1 follow-up session.



01 Interactive Group Lesson (1 hour)

Participate in an interactive group lesson on a specific topic over live video conferencing (maximum of 5-10 participants). Engage, review transactional documents, and ask questions in real time with lessons led by experienced practitioners.

02 Simulation Exercise (Approx. 1-2hrs)

Complete the “take-home” simulation exercise assigned in each module. The simulation exercise is designed to apply what you learned in the group lesson in the context of a “real-life” situation.

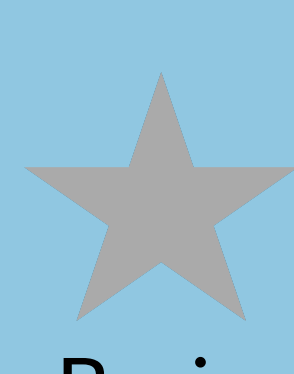


03 1:1 Follow-Up Session (1hr)

Schedule a private 1:1 follow-up session with an AltaClaro Instructor over live video conferencing to review your attempt at the simulation exercise and to help improve your technique. You can also dive deeper and ask follow up questions on the materials learned in the module.

Module Competency Levels

Modules are organized by level of competency and by practice area into “Course Series.” There are three levels of competency: Fundamental (Basic), Experienced Practitioner (Intermediate), and Advanced.



Basic

Fundamentals: Suitable for attorneys who have not had extensive practical experience in practice area interesting in developing basic competency. Basic-to-intermediate level modules.



Intermediate

Experienced Practitioner: Suitable for attorneys with some basic experience or knowledge in the practice area or in a related practice area looking to develop expertise. Intermediate-to-advanced level modules.



Advanced

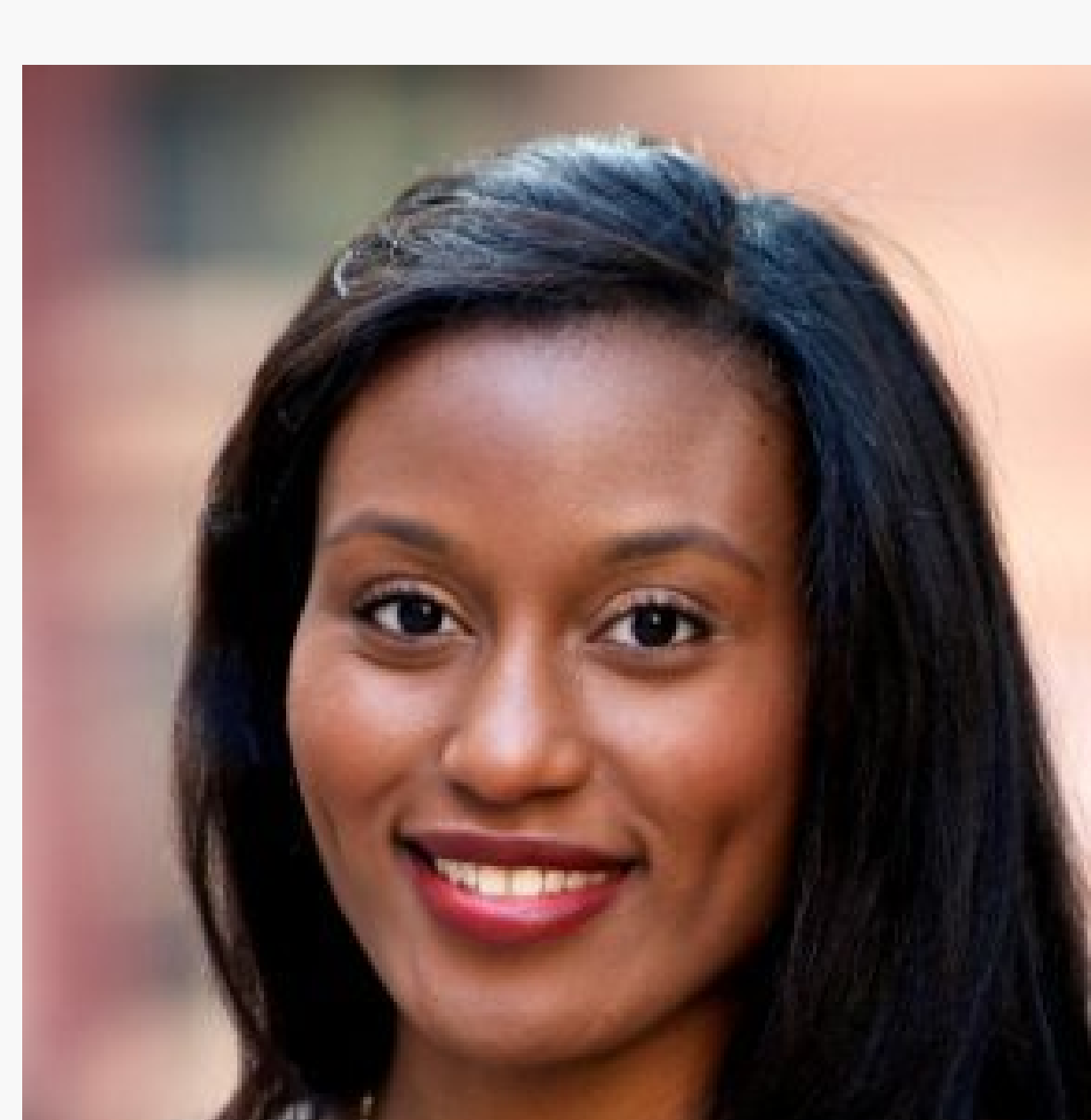
Advanced: Designed for experienced practitioners either interested in perfecting specific skills within their primary practice area, or in developing expertise in a related practice area. Advanced level modules.

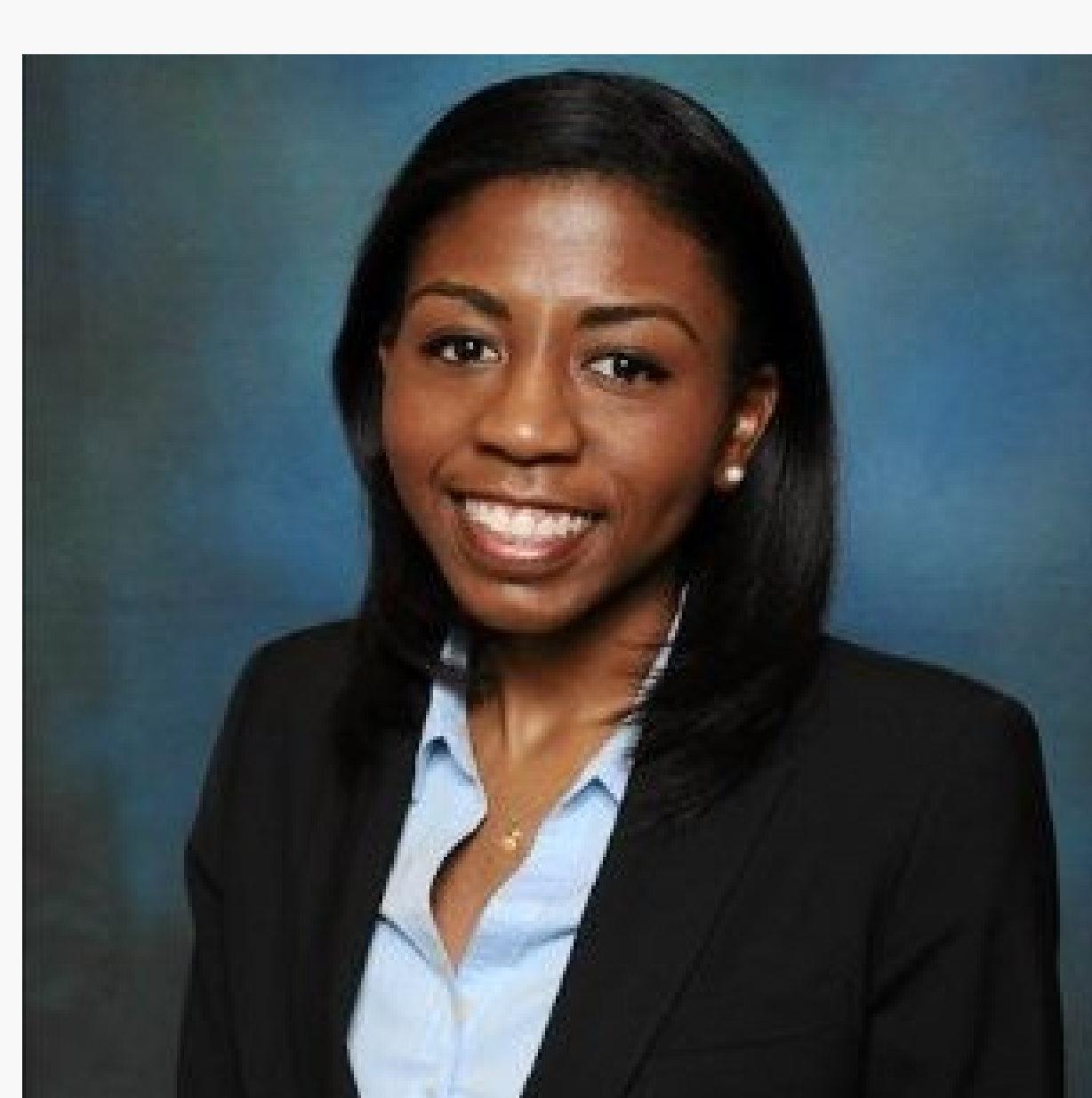
